General Directions

1. Registration of a Business Name is effected once only and not renewable according to sec.(5) of the Registration of Business Names Ordinance 1931 (Form, Business Name Registration).
2. Transfer of Ownership of a business name or change of Object or the Name requires the approval of the Licensing authority , pursuant to sec.(8) of the Ordinance (Alteration of Registered Particulars form.(legal form R.B.N.(3)) and the Registrar should be notified of that change during one month of its occurrence taking in to consideration the provisions of sec.(8) of the Ordinance.
3. Cessation of a business names is effected after notification of the Commercial Registrar of that, pursuant to sec .(9) of the Ordinance.
4. Registration of a partnership is effected pursuant to sec.(5)read with sec.(2) of the Partnerships Registration Ordinance,1933 (Registration of Business Name and Paetnership Forms) after the approval of the competent authority.
- 5.Alteration of particulars of a registered partner shop is effected pursuant to sec .(5) of the partnership Registration Ordinance 1923 (Alteration of the Businedd Name Form(Form R.B.N3)(Altration of a Partnership Form)(FormK3) after the approval of the Licensing authority.

Where the owner of a business name be a limited company, the following aer to be observed .

- 1.Completion of the file Company with the general loading determined in accordance with the provision of the Copanies Ordinance ,1925.
2. The nature of the business to be resisted must be included in the objects of the said company , in its Memorandum of Association.

Offences :

1. If any firm defaulted on presentation of the particulars required by the Registrar ir shall be liable to the penalty determined by the Court pursuant to sec.(10) of the Registration of Business Names Ordinance ,1931.
2. If the particulars included false information with the knowledge of the signatory to the particular. he shall of Business Name Ordinance 1931.
3. If a person defaulted in presentation of the required particulase or changes , his rights according to any contract he concuded shall be un executable, pursuant to sec.(15) of the registration of Business Names Ordinance , 1931.
